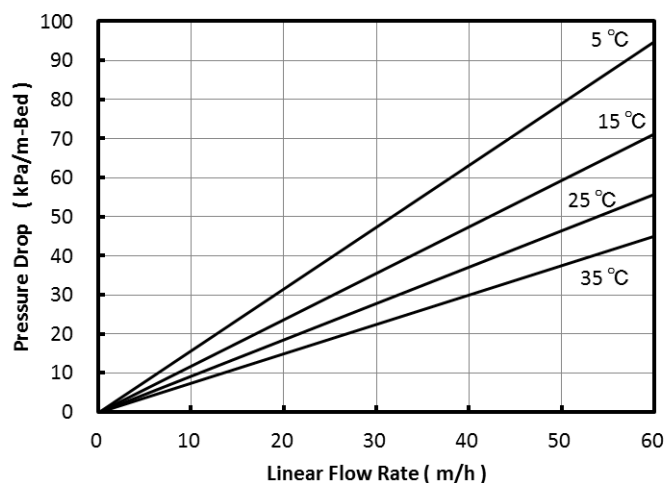


Fig. 1 Pressure Drop of SK1BH

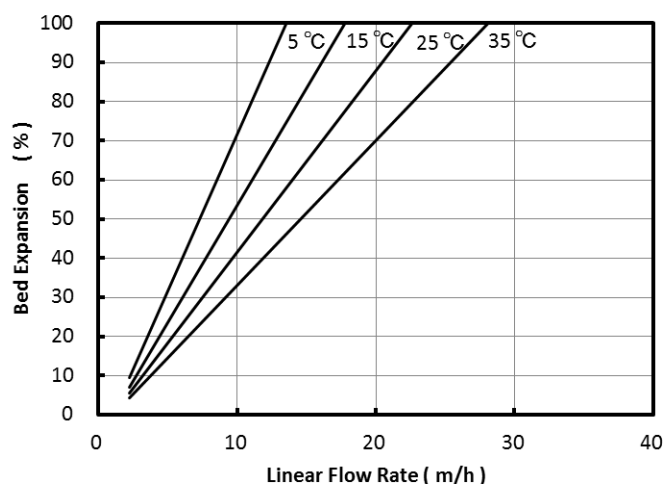


Fig. 2 Bed Expansion of SK1BH
